Dubai, 25th November 2013 – On Monday, DNV GL awarded Specialist Services the renewal of the DNV Manufacturing Survey Arrangement (or MSA) for their Al Quoz production facility with the arrangement extension to their production facility in Jebel Ali, confirming once again Specialist Services' high quality and reliable products manufacture.

Specialist Services have had an MSA with DNV for their Al Quoz facility since 2011, when it was awarded following a comprehensive Manufacturers Product Quality Assessment audit of the manufacturing facility, through which DNV GL carried out a thorough evaluation of the manufacturing system. The DNV MSA is incorporated within the company's ISO 9001 system and is maintained by the QHSE and Production departments.

"Naturally we are proud of the fact that an organisation such as DNV GL, a major global third party inspection agency, entrusts our quality system to deliver continuously conforming products with the minimum of inspection intervention" said Specialist Services' CEO, Ian Rogers.

An MSA (Manufacturing Survey Arrangement) is a production base assessment and is used as an alternative to the more typical "case-by-case" production procedure. The DNV MSA confirms that Specialist Services is authorised to perform testing, inspection and marking of containers during the manufacturing process, with limited attendance of the DNV GL Surveyor. It authorises the company to prepare production documentations and certificates, and these will be validated by DNV GL after final inspection of the units.

The DNV MSA is important for Specialist Services as it allows the manufacturing, testing and inspection of their own DNV 2.7-1 Offshore Containers and DNV 2.7-3 Portable Offshore Units throughout the build cycle without the need to call in DNV GL for intermediate in-process inspections. The DNV MSA is further recognition by DNV GL of Specialist Services' internal process and methods to consistently produce products which have a 100% acceptance quality.
